3. Review & pass meeting notes from January meeting:

a. No Questions. Minutes passed unanimously.

4. MSTCA Re-organization

- a. Lou Tozzi
 - i. The Board of Trustees met and reviewed the executive director and his role and intentions moving forward.
 - ii. Rick will continue as executive director through June 30th, 2021.
 - iii. Planning committee under Jon Monz as chairperson worked towards redrawing a plan for reorganization of the MSTCA.
 - iv. According to Lou this is the most important meeting we have had in his 40+ years on the E-Board.
 - v. The cabinet positions already exist.
 - vi. President, Vice President, Treasurer, Secretary positions are elected positions elected each June.

b. Jon Monz

- i. There were problems about how the organization was organized, especially the paid positions. Issues included a lack of communication and coordination among the paid positions, the blurring of the responsibilities, the lack of clarity behind the president and executive director, and confusion in terms of running day to day meets. It is not entirely clear of who is responsible for what. The job of executive director is a position that was not attractive to applicants due to the role description and time commitment necessary. The cabinet's principal role is to add communication between the BOT and EBoard and MSTCA membership.
- ii. The reorganization does 3 things.
 - 1. The elected President of the MSTCA is the leader of the organization.
 - It divides the responsibilities in such a way that people can feel comfortable in applying for these jobs and still maintain full time jobs and personal life commitments.
 - 3. Defines responsibilities of positions and a clear chain of command.

- c. Mike Glennon Question
 - i. What is the purpose of the Cabinet Chair? The responsibility seems large for an individual that would already be in one of the cabinet positions.
 Recommends that that position should be a position in and of itself.
 - ii. Len Harmon agrees with Mike Glennon. The Cabinet Chair should be a position in and of itself.
 - iii. John Monz would like current cabinet position holders to communicate their concerns regarding the workload.
 - iv. Kent Taylor said in season the workload is much more difficult than out of season.
 - v. Jayson Sylvain insurance is once a year, headquarters operation is quarterly rental payments. The idea is to have this individual plan things a year in advance.
 - vi. Len Harmon running the daily MSTCA operations seems like heavy lifting beyond what the letter points suggest.
 - vii. Lou Tozzi The Cabinet Chair role is not a one man show anymore like it was under MacIntyre and Mooney.
 - viii. Tim Cimeno We shouldn't be evaluating a job difficulty for a job that doesn't yet exist.
 - ix. Kent Taylor Our job roles are continually evolving and being re-evaluated.
 - x. Matt Carr we need to absolutely be ready to re-evaluate these job titles.
- d. Motion # 1 (Lou Tozzi via the planning committee) (Matt Carr moves) (Mike Glennon (seconded) unanimous no opposition and no abstentions.
 - i. 4 contractional positions and the current recipients remain the same through June 30, 2022. #3, 5, 6, 7 on the shared document
 - 1. Director of Marketing
 - 2. Director of Equipment and Logistics
 - 3. Director of Communications
 - 4. Chief Financial Officer
- e. Motion # 2 (Lou Tozzi via the planning committee) (Doyle seconded) unanimous no opposition Rick Kates abstains.
 - 4(a) Director of Timing Services in order to maintain stability in our organization we would like Rick Kates to continue in his role of director of timing services through June 30, 2022 in order to ensure continuity and stability through next year.
 - ii. Point of Information Mike Glennon Why is this point 4(a)?
 - iii. Lou Tozzi This role is not a member of the cabinet.
 - iv. Point of Information Mike Glennon Shouldn't we be planning our organization around job titles and not the individuals and what jobs we think they can handle.
 - v. Lou Tozzi We are looking to keep continuity during these tough times.

- vi. Jon Monz We have attempted to create an organization that allows the individuals in place to handle the positions we hold.
- vii. James Fletcher This position will be an overseer of multiple individuals that may serve as timers at any one individual event.
- viii. Charlie O'Rourke What direction are we headed in? Who is in charge. I feel like we are going in the wrong direction.
- ix. Jon Monz When Rick Kates said he was stepping down we realized we didn't have any potential candidates to take over. The job was too big and we had to divide it up. (See earlier statement from Lou Tozzi 3.C.vii)
- x. Open discussion with several members regarding the need to divide roles amongst multiple individuals.
- xi. Mike Miller We are unlike sports organizations that have only one competitive season. We have three competitive seasons that run from August-June. (We only get 1 month off). We should listen to the individuals who have been in leadership roles and are telling us the job is not a job for one.
- xii. Fred Doyle A good business has multiple leadership positions and mines the talent within the organization.
- xiii. Point of information Len Harmon 4(a) Director of Timing Services should be a position in and of itself and should be a cabinet position.
- f. Motion # 3 (Lou Tozzi via the planning committee) (seconded by Fletcher) unanimous no opposition or abstentions.
 - i. These new positions will be advertised in April and we will accept applications and have interviews in May run by the BOT.
 - We will have 3 season directors of meet operations (DMO 3 positions) -Cross Country - Indoor Track - Outdoor Track as well as Director of Special Events.
 - iii. These positions would expire in June of 2023.
- g. Motion # 4 (Lou Tozzi via the planning committee) (seconded by Pintzopoulos) unanimously approved with no opposition or abstentions.
 - The newly selected cabinet along with the President should develop complete job descriptions and work with CFO and Fin Com Chair to establish a salary structure for the upcoming fiscal year beginning July 2021.
- h. Motion # 5 4a Director of Timing Services should be included as a cabinet position (Len Harmon motion) (Mike Glennon seconded) Unanimous Vote no opposition or abstention.

5. Review Wheaton Meets - Jayson & Matt

- a. Matt Carr 6 meets so far with 1 to go this weekend. Numbers have grown each weekend. No Covid-19 issues to our knowledge. Financially we are at least breaking even (\$700-\$1300 range in profits).
- Matt Curran Boston Herald has great coverage of the meets over the past few weeks.
- c. Matt Carr National Record in the 55 meter dash was actually a season best performance and despite timing issues the individual has hit times very close to the time he ran that day.
- d. Lou Tozzi Crown Trophy plaques ordered for Wheaton College coaching staff

6. RCC – Letter to President

a. Frank Mooney - Asking RCC for refund of \$5,000 donation to the Mooney/McIntyre Fund. Other donations are calling back \$5,000 donations. Frank asked for their accounting 2019-2020 and lots of things were missing. Frank asked for a second request and we are not listed in their accounting. Questions were the money is going and what it is being used for.

7. MIAA XC/TF Committee Update

- a. Rick Kates sports medicine considers modifications (Tuesday-Wednesday), Covid Task Force (Thursday), MIAA Board of Directors (Friday) will vote and make the final decisions based on those recommendations. The Tournament Management Committee has made recommendations for no fall tournaments. Track & Field is getting the attention it deserves based on what he has seen at the meetings.
- b. Rick Kates Rotation of cross country divisional championships is being looked at by subcommittees. There is also a discussion regarding if all three All State Championships should be at one site. Wrentham can definitely handle the volume. Consideration needs to be made for course viewing ahead of time at venues. Fort Devens is a potential future site.
- c. Mike Miller Is East-Central-West a fair rotation? What about E-E-C-E-E-W.
- d. John Monz the subcommittee will look into this. The idea is that divisional meets will be held at the same location that the All State Meet would be held. For example (Divisions 1-2-3 would have their All State Meet at the same site while D4-5-6 and D7-8-9 will be at separate sites as well). Please bring up any suggestions, ideas, etc with us before the next subcommittee meeting in late February.

8. Virtual Clinic

a. Rick Kates - Go To Meeting offered a ridiculous price. Maybe a Friday night and Saturday with virtual meetings. Questions include (1) what we would charge and (2)what we would pay clinicians.

9. BOT meeting

15. MSTCA Membership Concerns

- a. Charlie Butterfield We only have 209 members (1/3 of what we had last year). 462 members have not renewed from last year.

- c. Mike Miller we need to show coaches that we need them to join
- d. Matt Carr we inadvertently created a disincentive by allowing Athletic Directors to sign up their coaches.
- e. Charlie Butterfield AD's don't have coaching staffs hired right now

16. New Business

- a. Frank Mooney MTFOA officials believe the meets are non sanctioned and non insured meets. Has been in communication with Steve Keyes. If we don't get our meets sanctioned with the MIAA we may have problems getting officials.
- b. Charlie Butterfield We just need our meets to be put under the MTFOA umbrella of insured/sanctioned meets.
- c. Rick Kates Is meeting with MTFOA tomorrow and will address these issues. By-laws need to be cleaned up to include MSTCA and not just MIAA.
