 - b. Charlie reported out on Officials Fees set at the recent GOC Meeting. With help from other members of the committee - the dual meet fee for the 20-21 school year (19-20 was already voted on and set) will be \$ 86.52 for indoor and outdoor track and \$ 79.21 for XC. The vote for a 3 % raise across the board passed plus the upgrade of Track (indoor and outdoor) to a base the same as basketball which is currently \$84.00.
 - c. The MSTCA will offer a clinic on the use of the electronic distance measuring device for Javelin and Discus. Up to ten stations will be available at the clinic. Location, date and time will be announced to members at a later date.
